


**Item No. 10 To report the recognition of Indian Law Institute, New Delhi as the Sustainable Campus**


The Council noted and appreciated the recognition of the Indian Law Institute as a Sustainable Campus and Swachhta Action Plan Institution.


**Item No. 11 To report various Academic/ Research and other Activities undertaken by the Indian Law Institute after the last meeting of the Academic Council**
