The Academic Council confirmed the minutes of the Academic Council held on 1 August 2022.


ITEM NO.2: To take note of the action taken report with respect to the above minutes

ITEM NO 12: To consider the request for migration to the Ph.D. Course at the Indian Law Institute




ITEM NO 13: To consider adopting the University Grants Commission (Minimum Standard and Procedures for Award of Ph.D. Degree) Regulations, 2022.


