The Council approved the above request of the student.

Allowing direct admission to Ph.D. without appearing the Entrance Examination

Ph.D being a higher research study, the Council advised not to dilute the quality thereof and to treat the matter strictly as per current Ph.D Regulation.

Application of certain autonomy as per the Gazette Notification F.No.1-8-2017 (CPP-II) dated 12<sup>th</sup> February, 2018, granted by UGC.

The Council noted and appreciated such new development in the academic arena in the country and appreciated that the Institute got the much deserved autonomy.

The Council after detailed discussion suggested to prepare a modules based on UGC Guidelines.

Regarding the financial assistance for participation of faculty members in National/International seminars and conferences, the Council suggested to prepare norms in line with UGC Guidelines on Travel Grant subject to approval of the Finance Committee.

The Council also approved onetime payment of Rs.25,000/ (Rupees twenty five thousand only) to one of the faculty member towards attending the summer school in 2017,subject to approval of the Finance Committee, in line with the financial support extended earlier on case to case basis .

Item No. 7 To report various Academic/ Research and other Activities undertaken by the Indian Law Institute after the last meeting of the Academic Council.

The Council after deliberation, appreciated various Academic/ Research and other Activities undertaken by Institute during the ensuing period and suggested peeping into more empirical research areas of contemporary nature. The Council also suggested that the Institute should modulate Law Teachers' Training, Research Methodology, Pedagogy and training modules for various legal stakeholders.
