
Item No. 2: To take note of the action taken report in respect of the above minutes

Item No.5: To provide information about NAAC Accreditation Cycle-II, this is due in March 2022

The Academic Council was informed that the institute is regularly submitting AQARs each year w.e.f., 2017-18 onwards (i.e., from the first cycle accreditation by NAAC) and that the submission of IQA & SSR is under process for the Second Cycle of the NAAC Accreditation, which is due in 2022. The Council was also informed that the validity of the first cycle accreditation has been extended by NAAC for all eligible Academic Institutions/Universities, till the completion of second cycle evaluation process, keeping in view the COVID 19 challenges faced by academics across the country.

Item No. 7: To consider starting the LL.D. Programme

The Academic Council decided not to introduce the LL.D. Programme.

Item No. 8: To consider reintroducing the PG Diploma in Labour Law beginning with the Academic Session 2022-2023

The Academic Council approved the reintroduction of P G Diploma Course in Labour Law beginning with the Academic Session 2022-2023.

Item No. 9: To consider the enhancement of fees for all academic Programmes:

The Academic Council approved the fees for various Academic programmes as follows:

Sl. No.	Programme	Revised Fees (Rs.)
1.	Ph.D. in Law	50,000/- Annual fee – 20,000/-
2.	LL.M.	1,50,000/- (69000/- per semester) (*2000/- University Enrolment & 2,500/- examination fee per semester and 5000/- security deposit refundable)

3.	PG Diploma Programme	35,000/- (28,000/- annual fee *2000/- University Enrolment, 2,000/- Annual examination fee and 3000/- security deposit (refundable))
4.	Online Programme	10,000/-

It was also decided that the revision of fee will be implemented w.e.f., session 2022-23. Continuing Ph.D. students of existing batches from previous years shall continue to pay the as per the old fee structure (i.e., Rs. 10,000/- as Annual fee) till completion of their course.

Item No. 10: To consider conducting the 6th ILI Convocation in online mode

The Council recommended that the original Degrees/Diplomas may be distributed to all the eligible past students (as per the list) excluding the current batch of students, i.e., 2021-22 batch.

The Council also recommended that in future only LL.M./Ph.D. students should be invited to attend the Convocation in person. The P.G. Diploma passed out students will be kept out of the purview of the Convocation and they will be distributed the certificates separately.

Item No. 11 To consider holding Entrance Test for admission to Ph. D. for all candidates (Non-NET/NET/JRF Qualified)

The Council decided that the entrance test should be conducted for all aspirants for Ph.D. (both NET and Non-NET) except for JRF qualified candidates.

Item No. 12 To consider paying token honorarium to external faculty for peer review/editing of JILI/ASIL articles

The Council accepted the recommendation to provide an honorarium of Rs.2000/- per article/chapter for peer reviewing of the ILI publications subject to the name of the reviewer being approved by the Academic Council.

Item No. 13 To consider fixing the minimum cut-off marks in Entrance for admission to LL.M. Course in various categories

After due deliberations, the Academic Council accepted the recommendation of the BoS and deferred the matter.

Item No. 14 To consider an amendment to the LL.M./P.G. Diploma Examination Regulations

The Academic Council approved the recommendation of the Board of Studies as follows:

LL.M.: A candidate who passes at least two papers in the regular semester examinations is eligible to sit for backlog papers in supplementary examinations.

P.G. Diploma: Candidates who pass at least two papers in the regular annual exams will be eligible to sit for backlog papers in the supplementary exams.

Item No. 15: To consider rescheduling of Gold Medals

The Council has authorised Director to constitute a subcommittee to look into this matter.

Item No.16: To report on various Academic/ Research Activities undertaken by the Indian Law Institute after the last meeting of the Academic Council


ITEM NO.16 (1): After extensive deliberation, the council decided that Ph.D. intake should be based on the availability of research supervisors, subject to maximum overall intake.


ITEM NO. 16(2): The Council noted the same.


ITEM NO.16 (3): The Council noted and appreciated the Ph.D. work.
